Terms and conditions

1. The promoter is Silverchain Care Pty Ltd (ACN 095 961 005) of Level 4, 20 Lexington Drive, Bella Vista NSW 2153 (Promoter).
2. The competition begins on 2 March at 8.30am AEST and closes at 5.30pm AEST on 5 March 2026 (Competition Period).
3. There are two Prizes, each being a \$100 Coles Myer gift voucher.
4. The competition is open to all NSW residents who are 18 years and over and who are in attendance at the Penrith City Council's Seniors Expo in Penrith on 3 March 2026 and/or the Central Coast Council's Seniors Festival Expo in Wyong NSW on 5 March 2026 (Eligible Person). Employees or contractors of Silverchain, its related bodies corporate, subcontractors and agents are not eligible to enter.
5. Eligible Persons may submit an entry during the Competition Period by completing an entry form and placing it in the box at the Silverchain stand at the Penrith City Council's Seniors Expo in Penrith on 3 March 2026 and/or the Central Coast Council's Seniors Festival Expo in Wyong NSW on 5 March 2026. Entrants must not submit more than one entry form.
6. The Promoter reserves the right to either allow or disallow any entrant for any reason it sees fit in its absolute discretion.
7. Entry to the Competition is free.
8. The four winning entries will be drawn at random from the entry forms submitted during the Competition Period on 6 March 2026 at 11am AEST.
9. The first four valid entries drawn will be the winners and will be notified by phone number or email address listed in the winning entry forms within 14 days of the draw.
10. All reasonable attempts will be made to contact the winners. If a winner chooses not to take the Prize (or is unable to), or does not take or claim the Prize by the time specified by the Promoter, or is unavailable, they forfeit the Prize.
11. The winners must claim the Prizes on or before 20 March 2026.
12. The Prizes must be taken as stated and is non-transferable, not exchangeable and not redeemable for cash. If the Prizes become unavailable for any reason, the Promoter may substitute the prizes of like or equal value.
13. The Promoter reserves the right to disqualify a winner, in its sole discretion, if the individual:
 - has breached any of the terms and conditions or their entry is misleading; or
 - tampers with the entry process, including exceeding any limitation on the numbers of entries, or any other process as determined by the Promoter that in any way affects the fairness of the competition.
14. If a winner cannot be contacted by 20 March 2026 the Promoter may conduct a re-draw for each Prize up to three times until a valid winner is found.
